Description: Procedure & Documents Required for Leasing on Overall Procedure for leasing on with ZAR Contracting LLC

- 1. Fill out new owner operator questionnaire https://airtable.com/shrizA6hCHBUJ9cNI
- 2. We will run an MVR and Insurance check, once we get the results we will send you the new owner operator set up documents.
- 3. Once we get all the required documents back we will schedule you for a dot drug screen. (We pay for this)
- 4. Once we get the results (normally take 3 business days). We will ship you the following.
 - a. Elog and cable
 - b. Window decals
 - c. Pilot/Flying J, Multi Service, EFS fuel cards
 - d. ZAR Owner Operator Manual
- 5. Once you receive your package, install the elog in your truck, put on the window decals, IFTA stickers, NYHUT sticker, and make sure your truck has all the dot required items installed/in your truck. See pages "List of items to keep in your truck" & Trailer bulk head instructions in your O/O manual.
 - a. If you receive hard license plate right away then you won't need the 45 day permits, if you don't receive hard plates then your 45 day permits allow you to run without plates.
 - b. ***Only display the apportioned license plates we provide, never display your personal plates! The truck plate goes on the front of your truck. The trailer plate goes on the trailer
 - c. The window decals go on your back windows
 - d. The IFTA stickers go on each side of your truck, we recommend putting them on the back windows below and to the right or left of the decals.
 - e. The NYHUT sticker goes on the front driver side bumper, you may not receive this sticker right away, if you don't then your NYHUT temp credential serves as your permit until you get your sticker.
- 6. Contact Kim to go over your owner operator manual and schedule your first load.
- 7. We will also email you copies of the following
 - a. Truck & trailer 45 day permits, truck & trailer cab cards, IFTA license, NYHUT C of R, NYHUT temp credential, Keep trucking manual, Blank BOL's, Spare log sheets
 - b. Driver load pick up & delivery links with instructions.

 - b. When you are loaded or under dispatch the liability and cargo are covered under our policy, the comp and collision on your policy. When you are not under dispatch the liability and comp/collision are on your policy. You will have both insurance certificates in your owner operator manual
